In each of these meetings I had the pleasure of meeting members of the Squadrons leadership and learning about their aspirations and concerns. I hope this tradition will continue in the future because it benefits members of the squadrons and the District Commander

In preparation for my year as the D/C I wanted to identify 5 issues that I should focus on during my tenure. The first and I believe the most critical issue is the decline in membership. I attempted during the last year to shine a bright light on the importance of focusing our attention on member retention. Yet as of December 31, 2018 the trend of decline in enrollment has continued and the District has lost 5.43% of its members since February 28, 2018. I hope that all of us recognize the urgency of this challenge and we do all we can to meet this challenge. MEMBER RETENTION MUST BE OUR HIGHEST PRIORITY, OUR CONTINUED EXISTENCE DEPENDS ON IT.

One of the common concerns I heard of my fellow members over the years is that USPS is not making enough changes to allow members to socialize during meetings. Some of my friends who decided not to renew their membership expressed that the reason for leaving is that they are not having fun. Another common complaint is that the Council meetings do not serve any purpose and they occupy the evening of the first part of the meetings. I think that the Conference's vote to revise the District Bylaws to eliminate the Council will streamline our Annual meetings and provide members the opportunities to socialize on the eve of the Conference meeting and have some Fun.

Two of the issues I wanted to address are related. As our enrollment declines, the District's income is decreasing. To make up for our deficits the District had started to use funds from our accumulated savings in previous years to balance the budget. I feel that this is not a sustainable solution to our problems. To address this situation, we streamlined the financial procedures to comply with the "Treasurer's Manual". This should provide members of the bridge a clear and standardized reporting of the financial position of the District and help the Commander and members of the bridge to appropriately manage their budgets. Another solution to our budget shortfall is to seek sources of income other than membership dues such as grants and gifts. The adopted Financial Procedure establishes procedures to manage grant and gift accounts in a manner that ensures that these funds are used only for the proposed designated by the Granting Entity and Donors. It is anticipated that these changes will encourage more of our friends to make gifts to support their favorite initiatives.

One of the issues I wanted to address during my tenure is to promote the need for us to establish clear and measurable outcomes of our activities, especially those activities that consume significant District resources. I also advocated the need that we use our efforts to ensure that we have indeed accomplished the desired outcomes. Using this strategy will certainly require more time and effort but it will help us direct our resources to projects that help us meet our objectives. I am pleased to report that my colleagues who are responsible for major District activities have adopted this philosophy and I hope this will make us more effective in achieving our goals.

This is my last message as the District Commander, and I want to thank you all for your generous support. I especially want to thank members of the Bridge, Committees and Officers. I had a lot of Fun and made many wonderful friends.



Always Prepared



While preparing to teach "Piloting" I was again reminded about always having the correct equipment to be prepared for anything. When I did my Boat Operator Certification skills demonstration for "Advance Coastal Navigator" I had to demonstrate having the correct skills to be prepared for anything.

There are several wonderful electronic versions of compasses available. Depending on how much money you want to spend and space on your boat you could have Fluxgate compass, Gyrocompass, and/or GPS compass. The "Mariner's Compass" seminar says these electrical dependent compasses are "excellent when installed in addition to a magnetic compass – but not instead of a magnetic compass". This statement not only applies to the compass, but applies across the board for all navigational safety gear.

There are many wonderful types of electronic navigation equipment. Your boat may have GPS with navigational software suite and radar. These make navigation easier than the traditional piloting methods. But what do you do when you're navigating in low visibility in an area you're not familiar with and the equipment fails. And don't kid yourself it will (and don't count on electronic backups), and I can provide several cases where everything electronic quit working.

Do you have reasonably current charts of the area, plotting tools, and the piloting skills to plot a course route, determine conversions from True heading to Magnetic/Compass heading, and Speed/Time/Distance calculations? Do you have a non-electronic method to determine your speed through the water? Do you have non-electronic methods to determine the tidal height and currents?

These are powerful and important skills and knowledge our excellent Education Department team can help you acquire. There are many classes available: Seamanship, Piloting, Advanced Piloting, Cruise Planning, and Marine Electronics as examples. Check your squadron's education schedule for this coming year for classes & when/where they're offered. Check with other squadrons about additional opportunities (including joint teaching). And why not share these skills with the boating public by helping teach.

Coast Guard responds to over 700 false alerts in 2018, urges everyone to properly register their device beacons

PORTSMOUTH, VA — After responding to over 700 false alerts in 2018, the Coast Guard is urging anyone with an emergency position indicating radio beacon to properly register their device.

An EPIRB is a device that transmits a distress signal to a satellite system called Cospas-Sarsat. The satellites relay the signal to a network of ground units and ultimately to the Coast Guard and other emergency responders.

Owners of commercial fishing vessels, uninspected passenger vessels that carry six or more people, and uninspected commercial vessels are legally required to carry an EPIRB. However, the Coast Guard recommends that every mariner who transits offshore or on long voyages should carry an EPIRB.

The Federal Communications Commission requires all EPIRB owners to register their beacons with NOAA and keep the registration information up-to-date.

If an unregistered beacon activates, the FCC can prosecute the owner based on evidence provided by the Coast Guard, and will issue warning letters or notices of apparent liability for fines up to \$10,000.

Coast Guard personnel were only able to contact 163 of the more than 700 EPIRB owners to determine the cause of the false alerts. The other individuals had not registered their beacons, not updated their registration information, or had disposed of them improperly.

"We handle EPIRB alerts with a bias for action," said Lt. Daniel Dunn, a command duty officer in the Fifth Coast Guard District's command center. "We have to treat them as actual distress calls until we can prove otherwise."

When Coast Guard watchstanders receive an EPIRB alert and cannot trace it to the owner due to missing or outdated registration information, they launch aircraft and boat crews to search the area for signs of distress.

It costs approximately \$15,000 per hour to fly an HC-130 Hercules airplane, \$10,000 per hour to fly an MH-60 Jayhawk helicopter, and \$5,000 per hour to operate a Coast Guard small boat.

"If people used this system appropriately, it would take a lot of the guesswork out of search and rescue," said Dunn. "Unregistered EPIRBs result in lost time, money, and the misuse of resources that could be used to save someone's life."

SUPER SEMINAR SERIES -- "PROPANE SYSTEMS ON YOUR BOAT"





The quiet evening at the marina in Sequim was suddenly rocked by a massive explosion. Nothing was left of the 38-foot, William Garden designed powerboat other than a floating field of debris. Nearby boat owners pulled the injured owner out of the water; he was subsequently airlifted to Harborview Medical Center where he died of injuries two-weeks later. The blast was so powerful that boats 75 feet away were damaged by the flying debris. Could this have been prevented? Absolutely!

This just-released America's Boating Club seminar on propane systems, gives you the knowledge you need to use propane fuel safely on your boat and to prevent such accidents from happening. Propane and butane, also known as LPG, are the most common cooking fuels used on boats. Our Experience using NEXUS to Cross the US Canada Border by boat both ways By P/D/C Mark Richey, SN

We took a trip to Sidney BC last summer and used our NEXUS Cards for the first time by boat. We based it on instructions from the web published by both governments. We had done it many times by car. It was a breeze and a joy by boat and this is what we did.

Heading into Canada

Our ultimate destination was Sidney but you could use that, or any other port of entry, as a waypoint. This was what we did and it worked well.

First, for this to work, <u>everyone</u> on board must have a NEXUS Pass. If not then the boat MUST stop at a port of entry and not use this process.

As we headed west around the end of San Juan Island, we set a waypoint where the International Border was. You need a minimum of 30 minutes to maximum of 4 hours to a designated port of entry. We waited a bit too long and were less than 30 minutes out when we called but it worked ok. When you are in Canada but between 30 mins and 4 hrs estimated out, the skipper must call Nexus at **1-866-99-NEXUS.**

They asked for our ETA and location of landing site. It must be on the "designated site" list which "Port of Sidney BC" was. (A hint here, if it's on your way, you may want to pick a check in site that isn't regularly manned as you won't actually have to touch shore or dock if nobody is there.) We would suggest, and this is only opinion, you don't pick Bedwell Harbor as that is the training site for Canada Customs and is always manned possibly with rookies.

They asked us for name and/or registration of boat. Since we are documented we only gave name. They also asked for the full names, DOB and citizenship of all NEXUS members on board as well as final destination and length of stay.

They finally asked for our NEXUS numbers.

They did not ask for permanent residence status or if we had any goods but they may.

They then gave us an entry number and said welcome to Canada. You need to keep the number for return to US. That was it.

The skipper is still responsible for the behavior, legality and administrative issues of all the passengers and if anything changes before actual arrival, needs to call in again.

The rules state that if an officer is not at the specified entry site at your ETA or at your actual arrival, you may proceed to final destination. Sidney is a phone in Port of Entry with a phone box on dock and is rarely manned unless they have come down to inspect someone for some reason. We only had to drive by the dock on way to our slip and saw that there were no officials there. The harbormaster told us that actually, once we had our number, we didn't even need to bother to do that. That may have been only Sidney but in any case, there was nobody official visible.

Returning to US Waters

A couple of suggestions to make life easier with this. Before you even leave on the trip you should consider doing 2 things.

If you are 30' or longer get a CPB user fee decal. This is yearly. You can purchase it when you call in your arrival but this makes it much easier and you won't have to have your credit card ready.

Call CPB and get a VR number. You may have to use ROAM to do this now but it's handy. That basically puts all your boat info etc. in the system and they may not even ask you some of the questions. One of the first questions we were asked is if we had that number.

Ok. This was just as easy as going into Canada. It was somewhat different but similar.

We came back from Canada the same way we went in by going around north end of San Juan Island. There is no time limit on this and you just need to call in after entering US water but before you reach a port or anchorage. (This is only for Alternate Inspection Programs like NEXUS).

I called CPB at **1-800-562-5943** someplace in Spieden Channel. This number is for Puget Sound arrivals only.

This is what was asked of us in order:

- 1) Our full names, date of birth and citizenship
- 2) Boat name and registration as well as manufacturer.
- 3) Did we have a VR number? (If we had they may have reduced some of the questions)
- 4) CPB decal number. (If we did not have one we could pay for it right now during the call and the sticker would be mailed)
- 5) Current location (This is your GPS coordinates) and destination. Your destination does not have to be a valid port of entry, just where you plan on ending up that day.
- 6) Finally they asked for a return contact number and gave us our clearance number.

They asked no questions about declaring anything or if we were bringing in food or anything. I imagine that they could but chose not to. The guy I spoke to was very friendly and helpful about how to get VR info etc. He walked me through giving current location as I had originally thought it was something like "North End of San Juan Island". It may have been I was a first timer but he was very cheerful.

That was it, we were cleared. We did not have to do anything else. They could have asked us to stop at the nearest port of entry but have heard this is rare doing it this way.

Again, everyone on board has to have a NEXUS card.

Note: There is a new smartphone app, CPB ROAM, to try for Washington and Alaska but the above method will still work.
