Wow what a year! Who would have thought it is approaching eighteen months since we last gathered in person as a district. If trends hold it could twelve more.

The pandemic of 2020 sent shock waves through the world and our organization; akin to a tsunami. Instead of total destruction from a massive tidal wave, what we got was a slow but endless flood; destroying most of our possessions (old ways and ideas) but leaving us and

our homes basically sound. Now, without our familiar possessions we were forced to find new ways to communicate, carry on with our lives, keep in contact with those most dear, and achieve our social and education goals.

Many I have spoken with see the pandemic as a bad thing, upsetting everything. I choose to focus on the good side a see paths new opportunities for renewal. For many years we, within USPS, felt stuck; frustrated with our diminishing and aging membership, lack of a clear future and especially how to reach out to those younger than us. Many felt helpless or afraid to start changing in a rapidly evolving world. Well, I am happy to say that those endless, non-receding flood waters of the pandemic have helped us by forcing us to change; and change we did!

As I look back and see the marvelous ways our district's squadrons have changed now that most of their legacy property (old ways) have been washed away; I am so pleased. Squadrons have now embraced the current age and are keeping in contact with their members electronically. They are creating new ways to stay engaged with their memberships and even reaching beyond to sister squadrons. They have embraced new ways to teach, bringing quality education and information not only to those nearby but also afar. One squadron has an ABC student in far East Asia. Squadrons such as Deception Pass, Friday Harbor, Bellevue and others reached beyond their membership for their monthly GMM presentations. Before the pandemic I never would have traveled from my house on San Juan Island to Deception Pass just to sit in on a one hour presentation but I attended electronically and enjoyed it. Bellevue brought in two National Planning Committee members to speak on the transition to America's Boating Club. One Plan Com member was in North Carolina. This would not have happened if not for the pandemic.

Due to the pandemic, SEOs are reporting students enrolling from many different places such as East Asia and Puerto Rico. While these students may never become squadron members, the shear fact that they sign up from so far away is a validation of what these dedicated SEO's do and the educational opportunists they offer. Today many of our advanced education efforts are hampered by the NEO and others obsession with proctored exams. As more and more courses move online and we expand our reach, I suspect we will see a National realization that: "If we are self educators than cheating only cheats oneself."

As I write this the 2021 USPS virtual Annual Meeting has just started, kicked off by the D/C, DEXO meeting. This meeting is where your top two district officers meet to discuss what is happening within USPS. While I was pleased with the overall energy exhibited by all, I must tell you that many in attendance still have not embraced the changes we must make to meet the challenges of today. After a three hour meeting, it was only at the end when one D/C asked why we had not even discussed America's Boating Club. The meeting was mostly business as usual; the same things just dressed in different clothes. I have attended eight of these meetings since 1999. If we are to keep moving forward to become America's Boating Club, than we must stop just changing clothes each year and truly embrace this new concept, not ignore it.

Having worked on the National level to help define it, I will tell you what is "America's Boating Club". America's Boating Club is the United States Power Squadrons, only lite. It embraces our heritage while acknowledging simpler and more fun way to do things. It sheds, only if you want, most of the burdensome requirements for endless reports and committee positions. It focuses on the desires of its members to

enjoy comradery while achieving a sense of pride in helping others. It does not get caught up in its own self importance, but rather acknowledges why individuals chose to join. An ABC squadron does what is necessary to survive and evolve in its unique demographic environment. It becomes what its members wish, becoming as formal or informal as desired. It must meet only four requirements: (1) Have a Commander (President), a Secretary / Treasurer and an SEO. (2) Offer an ABC class once a year. (3) File its 990 form. (4) Submit Merit Marks. Anything beyond that is up to its squadron and the desires of its

members. In essence ABClub is not a USPS focused on its procedures dictated in a very thick Operations Manual but a USPS focused "On You and for You."

This message to you marks my last as your DEXO. In a few weeks, if you choose, I will step in as your D/C. My biggest regret is that our current D/C, Craig Brown, could not have had a better, more social year. In all my 34 years attending district meetings Craig is probably the finest D/C I have known. His dedication to detail and true desire to be there for the membership no matter at what level they are, it is truly unique in a leader. Another regret is the lack of opportunity I had to personally visit all of our squadrons, create friendships with some of those members and experience their hospitality.

Welcome to a new year. Despite the sunshine pouring in thru my study window, it is still cold outside, and reports from *Punxsutawney Phil* is that sunshine isn't due for six more weeks. Still, COVID restrictions have eased somewhat, and I have heard from several squadrons in our district that planning for spring classes proceeds at a decent pace.

I have been told that ABC and Advanced Grade classes were held in the virtual world successfully in January, I hasten to add.

I assisted the Everett Squadron with an 8-hr ABC Class spread over 4 two hour ZOOM sessions, followed by a parking lot test administration that graduated two students, both of whom have expressed interest in membership. Bellevue is working on getting additional instructors qualified for public instruction, and Deception Pass presented an ABC Class via ZOOM which graduated 16 students. So our education efforts throughout the district are making a difference. As Spring approaches (and the days are getting longer, a little) and the boating season opening up, we have more opportunities to get our message out to the public. As the vaccine starts to work in the general population, perhaps (just perhaps, mind you), in person classes may become possible once again.

Still, distance learning is here to stay, and we as USPS educators need to make sure that our skills are improving along with the technology. I know of one elective class being held that includes students from Everett and from San Juan, Puerto Rico and another that includes a student from a Pennsylvania Squadron. I hope that this will continue to be a good way of getting our message of Boating Safety Education out to a wider population.

On a more administrative note, Change of Watch season is now upon us. National is requesting and strongly urging that we use the on-line ED-80 form to record new officers and committee chairs. This can be a little tricky as the national website can be, well, counter-intuitive from time to time. Also related to Change of Watch season: In years past, we have held an Educational Summit/ Seminar for SEOs (and other interested parties) to get together and exchange information. A number of SEOs this year have told me that our monthly ZOOM calls are a more efficient and effective way for us to communicate, without having to commute some place. Because of that, and the COVID crisis, I have elected, in consultation with the district commander, not to hold an in person Education Seminar this year. 
#### The Virtual Meeting Options



New Members – remember you do not have to wait for an invoice to pay the district dues. A few squadrons pay the new member district dues at the same time as they pay the national dues. The easiest way is to write the District a check at the same time as you pay the National Dues.

990N – As we end one year and start a new one, it is time for each Squadron to file a 990N with the IRS. Please forward to me a copy showing that the form as been accepted.

By now all Squadron Treasurers and Commanders should have received notice from National that squadron assessments and Educational fund payments can no longer be included in the check for payment of National dues. Education fund payments must be made separately. Several Squadrons just mail a check for \$1.00 for each member directly to the Educational Fund in July.

District dues will remain the same for the coming year.

#### **NEW Marina Survey Program**

This article describes the marina survey program. Included are the reporting options and a discussion on its purpose and reporting frequency. Suggested preparations and materials for conducting the survey are presented so that you will be well prepared in advance of the survey. The requirements for conducting a survey and credits awarded for approved reports are also described in detail. After a survey is completed, you will want to complete the appropriate form and worksheets that make submitting a report a rewarding experience. All reports should be submitted to the Cooperative Charting Committee using the submittal form on the Cooperative Charting website. The data for the report is to be provided on the appropriate form that will be uploaded along with any pictures, chartlets or other associated documents. A member of the Cooperative Charting Committee will review the report and assign the appropriate number of credits if approved. After the report is approved, the information will be forwarded to Cruisers.Net for them to update their marina database information. If errors are found or the information is incomplete, the submitter will be advised via email of what actions are needed to gain acceptance.

The Cooperative Charting year will be from 01 January to 31 December and reports must be submitted within 30 days of the observation, except for reports done near the end of the year. To be counted in the current year, reports will need to be submitted no later than 15 January of the following year.

## DAN BOATER BY LT/C LINDA MARTIN, JN -- AUGUST 2020

There are angels watching over you!

Mike and I got up super early on Wednesday, February 12<sup>h</sup> and drove to the new Paine Field Airport packed and ready to attend the USPS National Meeting at the Sawgrass Hotel and Spa, Florida. Beautiful airport I might add at Paine Field.

While changing planes in Denver, CO I tripped over Mike's foot, fell and broke my right hip. Here's where the "angels" came in. Right away "Tim" an EMT from Oklahoma rushed to my side and comforted me until the EMT's from Denver Airport arrived. "Melissa" a United Airlines supervisor was also in the area and called 911 and got information from Mike. She also got our luggage off the plane so it didn't go on to Florida.

Meanwhile I am in a pain level of 12 and am being rushed to the University of Colorado Hospital. This is probably the best hospital in Colorado. After two sets of x-rays it is determined that my hip is fractured and I will require a partial hip replacement.

My surgery was very successful on February 13<sup>th</sup> and recovery took about a week in the hospital with great nurses and doctors at my side.

When Mike called Annette in Florida to tell her of the accident, she suggested he call DAN Boater Travel Assist Insurance that the USPS had currently partnered with. He did and they called him every day to check in on my progress and his needs. They were "all in" on our dilemma. In the end they covered the cost of our transportation from the hospital to the airport.

We learned if we had continued our trip to Florida, go on a boat and went out to sea and then I broke my hip, DAN Boater would have covered and handled the transport to a Florida hospital and covered or trip back to Washington.

Melissa from United Airlines also contacted Mike every day, delivered our luggage to Mike at the hospital, helped with rescheduling or flight back home and met us at the airport with two wheelchairs and helped us through security, bought us snacks, took us onto the airplane to make sure we were treated well by the staff on the plane. She then called us when we got home to check in again.

Lesson 1: DAN Boater Travel Assist Insurance is a must for all travel needs; you never know when you will have an accident and need their assistance rescheduling your flight back. The cost is only \$25 per person or per family per year. A bargain at twice the price.

Lesson 2: Buy Travel Insurance when you fly. United Airlines reimbursed us for the entire flight and Mike for his hotel costs in Denver.

Lesson 3: Last of all be thankful for all those angels who come to your aid when you are hurt. I am so thankful, especially to Mike, for all he has done to stand by me (and sit by me) through this ordeal.
